| HOSPITALITY  |  |
|  | Green room. Comfortable backstage area appropriate for relaxing, eating snacks, and preparing for the performance.   |
|  | Dressing rooms. Please ensure adequate dressing room space for 6 adults to change clothes comfortably and privately. Please provide at least 1 clothing rack per dressing room, as well as 1 iron, ironing board and/or steamer.   |
|  | Restrooms. Venue should have at least 1 artist-only restroom, preferably backstage near dressing rooms / green room.   |
|  | Snacks / drinks.  - Non-carbonated bottled water. Minimum 12 twelve-ounce bottles per performance.  - Coffee, hot water/tea.  - A variety of light, healthy snacks, which may include fruit/veggie trays, cheese/deli trays, chips and hummus, bagels and cream cheese, granola bars, and/or other similar food items.   |
|  | These items should be on-hand during the scheduled sound check time. Location can be backstage, green room, dressing room(s), or wherever makes most sense for the space available at the venue.   |
| MEALS  |  |
|  | For evening performances, purchaser will provide 1 hot dinner meal for 7 adults on the day of each performance. In most cases, because of time constraints, this meal should be served approximately 2 hours before the concert and should be catered or delivered to the venue. Different accommodations may be negotiated on a case-by-case basis.   |
|  | If the engagement involves a daytime performance or educational outreach before or around lunch time, purchaser will also be responsible for providing a lunch meal for the band and crew.   |
|  | Please note: one m-pact band requires a gluten-free meal option. Additionally, one band member requires a gluten-AND dairy-free meal option. Thanks in advance for your accommodation. Lastly, when possible, the group always enjoys local food or restaurants that may be unique to your area. This is not required, and may not always be feasible. But, whenever possible, we love to experience the varied 'flavors' of the communities we visit! |
